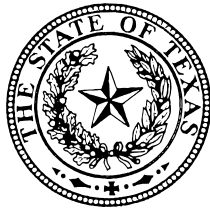

ANGELINA COUNTY DRUG COURT PROGRAM Sanctions

I understand the following sanctions may be taken, but the Judge has the authority to modify the sanctions as needed:

Positive Drug-Test:

- 1st violation**-one weekend in the Angelina County Jail. "Good time" will not be granted. Loss of any time accumulated in the program.
- 2nd violation**-three consecutive weekends in the Angelina County Jail. "Good time" will not be granted. Loss of any time accumulated in the program.
- 3rd violation**-recommendation for in-patient treatment or a violation report will be filed.

Failure to Attend Treatment Group (unexcused):

- 1st violation**-one week extension in counseling and three hours of community service. Community service must be completed before the next meeting with the Community Supervision Officer.
- 2nd violation**-two week extension in counseling and six hours of community service. Community service must be completed before the next meeting with the Community Supervision Officer.
- 3rd violation**-treatment team meeting to consider removal or continuance from the program. If the participant is continued in the program three consecutive weekends in the Angelina County Jail will be assessed. "Good time" will not be granted.

Failure to Report to Community Supervision Officer (unexcused):

- 1st violation**- one weekend in the Angelina County Jail. "Good time" will not be granted.
- 2nd violation**-three consecutive weekends in the Angelina County Jail. "Good time" will not be granted.
- 3rd violation**-treatment team meeting to consider removal or continuance from the program. If the participant is continued in the program three consecutive weekends in the Angelina County Jail will be assessed. "Good time" will not be granted.

New offense:

- Felony charge-Immediate removal from the program and a violation report filed.
- Misdemeanor charge-treatment team meeting to decide if a violation report is filed or if continuance in the program is justified.

Failure to Participate in Treatment:

- One week of counseling added for each infraction for a maximum of four weeks. Discharge will result from the program after the fourth infraction.

Failure to Provide Drug-Test

- 1st violation**-one weekend in the Angelina County Jail. "Good time" will not be granted.
- 2nd violation**-three consecutive weekends in the Angelina County Jail. "Good time" will not be granted.
- 3rd violation**- recommendation for in-patient treatment or a violation report will be filed.

Tampering with a Drug-Test:

- 1st violation**- three consecutive weekends in the Angelina County Jail. "Good time" will not be granted.
- 2nd violation**- Immediate removal from the program and a violation report filed.

Failure to Report to Court (unexcused):

- 1st violation**-one weekend in the Angelina County Jail. "Good time" will not be granted.
- 2nd violation**-three consecutive weekends in the Angelina County Jail. "Good time" will not be granted.
- 3rd violation**-consideration for in-patient treatment or a violation report will be filed.
