II : Current Policies to be Reviewed

1) Delay Report

Current Policy: *Delay Report (Effective 11/17/11)*

In an effort to help maintain employment for participants receiving a jail sanction, delay reporting may be given on a 1st Jail sanction. Participants may report by 5 p.m. Friday the day after their court session. If a participant chooses to delay report then they must drug screen on Friday during a.m. screening.

2) Sanction for missing Court and not AWOL

Current Policy: 7 days Jail if not a documented emergency + Missed screen

3) Creatinine cutoff for dilute specimen

Current Policy: Dilute = Creatinine below ~~18~~ mg/dL (as of 6/21/12)???

4) Review Fines and Fees Revocation Hearings and follow through with finances

Current Policy: Place on Calendar for Fines and Fees if total arrearage is over \$300.00; Standard revocation 28 days suspended upon weekly payments of \$30-New Hope, \$30 Probation, \$15 Tx Services, if unable to make payments due to unemployment or loss of employment then 30 hrs a week of combined Job Search/CSW;

Failure to comply: 1st = 2 days Jail (can be delayed up to a week);
2nd = 4 days Jail
3rd = 8 days Jail

can be handled in court

make sure we put it down when pymt missed

5) Moving w/out Notification

Current Policy: 2 days in jail for moving residences without prior notification if they are not on curfew
2 days in jail and missed drug screen if they are on curfew

6) Curfew

✓ Current Policy: 30 minutes travel time to get to and from meeting

Discuss issue of participants not following procedures on getting curfew adjusted ahead of time (employment)

7) Supplements and Amphetamine Positives

Discuss ongoing issue of supplement use and amphetamine positives

Current Policy: 4 hrs CSW for missed Job Search
2 hrs CSW if late to Job Search
